Regular Meeting of Council for January 30, 2024

Presentation - Draft Audited 2022 Financial Statements

Council heard a presentation from KPMG regarding the Draft Audited 2022 Financial Statements and passed a motion to approve the consolidated draft financial statements for the year ending December 31, 2022.



Proclamation - Wear Red Day

Council proclaimed February 13, 2024, as Wear Red Day in the Town of Greater Napanee.

Proclamation - World Thinking Day

Council proclaimed February 22, 2024, as World Thinking Day in the Town of Greater Napanee.

Proposed Amendments to Flag and Proclamation Policies

Council received a report on the Proposed Amendments to Flag and Proclamation Policies. Council directed that the proposed policy amendments be brought to the February 13th meeting for adoption, subject to any revisions requested at or before that meeting.

Town of Greater Napanee and Town of Deseronto Transit Pilot Partnership

Council received a report on the Town of Greater Napanee and Town of Deseronto Transit Pilot Partnership. The new partnership with the Town of Deseronto offers 10 stops within Napanee via a 16-18 passenger bus equipped with accessible passenger seating from Monday to Friday from 5:00 am until 7:00 pm. Grant funding to initiate a public transportation system has been made available and approved through the County of Lennox and Addington for an amount of \$186,000, to be used prior to March 31, 2025.



Proposed Sale of Surplus Property to Algonquin Lakeshore Catholic District School Board

Council discussed the proposed sale of the vacant lot adjacent to the JJ O'Neill Catholic School and behind Simcoe Street to the school board for the purpose of expanded parking to assist with site traffic flow and safety. Council moved to defer a decision to the February 27, 2024, meeting to allow more time for public comment on the matter. Street Naming Policy Update

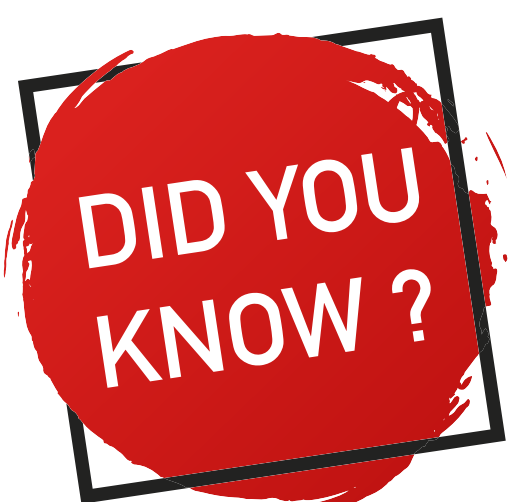
Council received a report for information on the Street Naming Policy Update and directed staff to begin soliciting street names from the public for Council's consideration in developing an Approved Road Name Inventory.

Community & Corporate Services

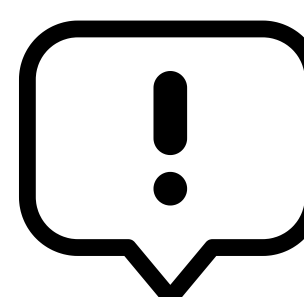
