Deputation

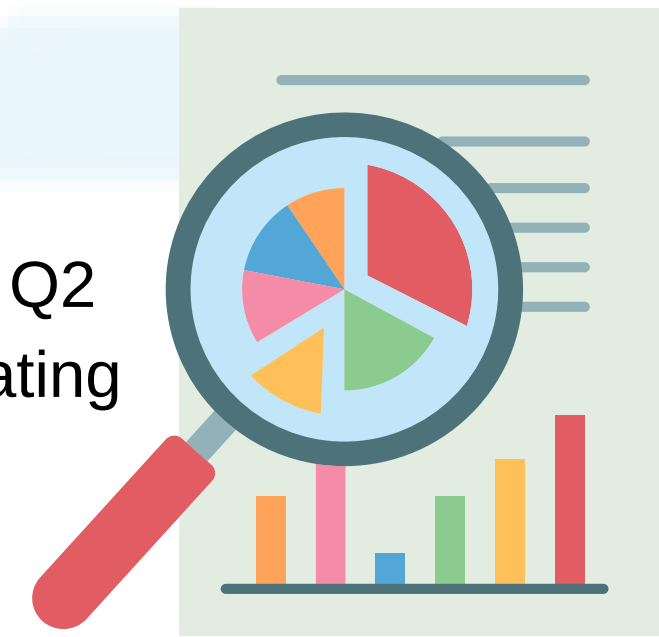
Council heard a deputation from Potentia Renewables about a proposed Quinte Energy Storage Centre (ESC). The presentation outlines the proposal of an advanced compressed air energy storage project in Greater Napanee.

2023 Business Plan Mid Year Update

Customer Service and Complaints Management Policy Suite

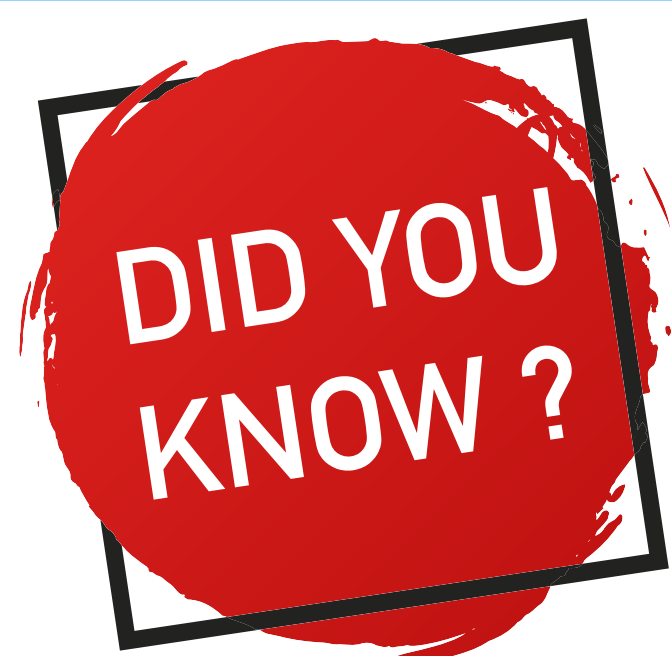

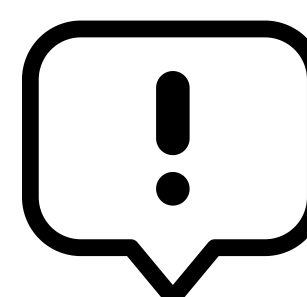
